The institute's approach is to go beneath the surface to discover hidden resources that can be leveraged, along with more visible resources, for the economic, social, and cultural development of the community.

Wildflowers Institute received a grant from ArtPlace America to address more equitable, integrated development in the Tenderloin, a neighborhood that is being gentrified and where artists and low-income residents are being displaced.

The institute's strategy was to identify and map the cultural assets of the Tenderloin. The staff canvassed single-room occupancy buildings, held one-on-one meetings and focus groups with local artists, and conducted site visits to where the artists lived through this survey. Wildflowers uncovered a sustainable creative force in the Tenderloin of six hundred and fifty artists. Half of them are independent, self-taught artists working in their own single-room occupancy space. This galaxy of artists constitutes a self-organized community art incubator.

Wildflowers also held a Hidden Artistic Gems Awards Program in the Tenderloin to surface some of the remarkable talent in the neighborhood. The institute provided grants of \$1,000 per artist to sixty artists for their artwork and stories of the Tenderloin. We also gave a \$50 gift certificate to more than fifty artists who submitted artwork for consideration of a grant but did not receive an award. The Hidden Artistic Gems Awards Ceremony was held on November 13, 2015. More than three hundred artists, local residents, nonprofit executives, business leaders, and public
