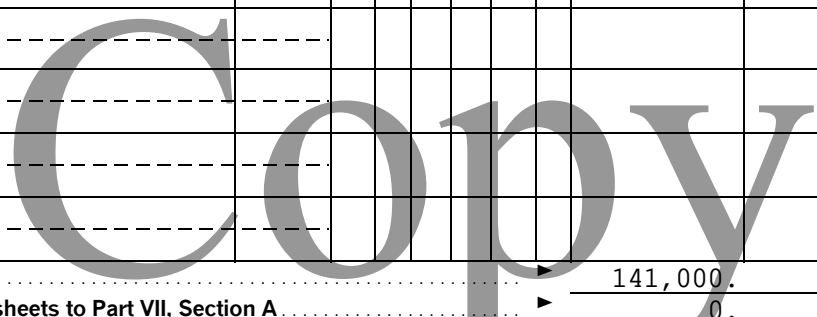

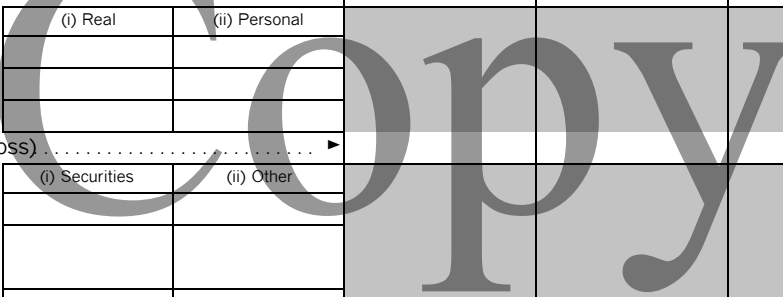

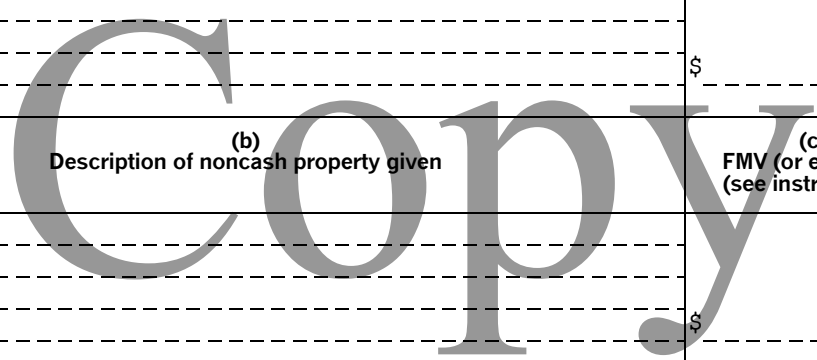

Wildflowers' mission is to harness the energy of the community for the social good. The institute cultivates organic growth from the bottom-up and the inside-out—this is the surest way to sustain social change in a community.

We build trust after we enter a community and learn about its people, its place, and its North Star. We discover the formal and informal structures of its ecosystem, and we strengthen how the ecosystem is organized and how it functions. We go beneath the surface to reveal the energy that is the critical mass for change, and we incubate local resources and cause a "ripple effect." We help unite the community beyond its borders.

Form 990, Part III, Line 4a - Program Service Accomplishments

At the beginning of 2016, the institute established a cultural arts incubator to explore the role of artists in strengthening the culture of the Tenderloin. We invited a diverse group of artists to see if the insights about their life experiences and expressed in their artworks would inspire other artists and produce a ripple effect in the neighborhood. They shared stories of their journey and the challenges they faced. And what emerged was a deeper understanding of who they are. Carl Jung wrote, "It is only through a crisis that development of the personality occurred." The artists also became more conscious of what it is about the Tenderloin that makes it a sanctuary for the wounded—premises that insist on being free to be, on giving a helping hand to strangers, on healing, and on accepting differences. We are seeing the power of community art and the role of artists in bringing out many points of view and interpretations of situations in this neighborhood. All this learning from the artists in the incubator is helping us understand how they are sharing

stories of the neighborhood and attaching meaning to places.

"Healing in the Aftermath of a Fall" was the title of the artwork developed by Tenderloin artists in the incubator, and it was performed at the Wildflowers celebration, Reinventing and Renewing Communities, on December 7, 2016. Over 230 people attended the event, and the artists received a standing ovation after their performance.

We also helped Wildflowers fellows to think more deeply about how their communities are adapting to their local environment and reinventing and renewing themselves. Their ability to become better suited to their surroundings is essential to their survival and sustainability. All of them are building on the collective wisdom of their family and ancestors. They pass down the knowledge and spiritual and cultural practices from one generation to the next, and they make modifications to adjust to their locale. The leadership of our communities has developed a capacity to discern what worked in the past and what changes should be introduced and embraced in such a way that communities can renew traditions of collective aspiration, shared endeavors, and creativity without losing their true nature and culture. At Wildflowers we are of the opinion that the continuity of experience is the key to developing discernment and, more broadly, community intelligence. In 1938 John Dewey wrote the following in his book *Experience and Education*: "The principle of continuity of experience means that every experience both takes up something from those which have gone before and modifies in some way the quality of those which come after." To bring attention to the importance of thinking collectively about what to accept, what to reject from the outside, and what to give up from the past on the inside, we decided to bring our communities together to share different ways of adapting to current situations and

local environments. We established a learning space to explore how different social formations adapt to their environment. At the Wildflowers event at the Yerba Buena Center for the Arts on December 7, 2016, we highlighted the work of the Lao Iu Mien in Northern California, the Red Wolf Band in Albuquerque, New Mexico, the Ethiopian community in the San Francisco Bay Area, and the black community of Seattle's Central District. We spent half of the event sharing knowledge and experiences of communities, and the other half watching the art performance on self-improvement titled "Healing in the Aftermath of a Fall."

We are so excited about how the community innovates and makes good things happen. Our evidence is found in twenty places Wildflowers has worked in that touch the lives of millions of people. Since we started this learning journey over twenty years ago, more than 100 informal and formal leaders have been meeting at Wildflowers and at their locales. We are deepening our knowledge of how they deal with the complex social problems they all face today. This knowledge is contributing to an emerging value-based and moral social order for sustainability in coming decades.

In 2016, Wildflowers was selected to be on the Yerba Buena Center for the Arts 100 list of change makers who determine how culture can be a catalyst for societal change. Also in 2016, Wildflowers was invited to give a presentation at the Association of American Colleges and Universities on January 27, 2017, and to give a keynote speech on "Sustainability and Innovation" to 500 staff members at the Iowa State University Extension and Outreach Annual Conference in Ames, Iowa, on March 27, 2017. The Extension will reach out to one million people directly in Iowa using Wildflowers social model of sustaining change in communities.
